uMngeni-uThukela Water is calling for SMME's to register on the Enterprise and Supplier Development Database. Emerging Micro Enterprises (EMEs) and Qualifying Small Enterprises (QSEs) with CIDB Grades 3–7 will be considered. This invitation is for enterprises that are based in KwaZulu-Natal as indicated in their current Central Supplier Database (CSD). uMngeni-uThukela Water is targeting established, financial viable Enterprises with a substantiated record of creating employment.

uMngeni-uThukela Water is establishing an Enterprise and Supplier Development programme to facilitate the constructive and meaningful participation by the **designed groups** in Local Economic Development within Kwa-Zulu Natal. uMngeni-uThukela Water is calling for Black owned Enterprises in **its area of Operation** (eThekweni Metro, Msunduzi, uMgungundlovu, iLembe, Ugu, Harry Gwala, uThukela District & King Cetshwayo) to apply to be included in uMngeni-uThukela Water's Enterprise & Supplier Development programme.

uMngeni-uThukela Water is interested in Enterprises that are involved in the following:

- Development, Extension, Installation, Repair, Renewal, Removal or alteration of corrosion protection systems (cathodic, anodic and electrolytic).
- Development, Extension, Installation, Repairs, Dismantling of precast walls, Installation of wire perimeter fencing,
- Diamond perimeter fencing, Palisade steel fencing with posts and stay at intervals.

Only EMEs and QSEs that are at least 51% Owned by

- Black People
- Black People Military Veterans
- Black People Who are Youth
- Black People Living with Disabilities
- Black People Who are Women
