Competent and experienced Contractors are invited to Tender for the following:

Refurbishment and Renovations of the control room and Plant laboratory at Nsezi WTW. The work entails conversion of existing old Nsezi WTP laboratory into a control room with a section area for on-lining testing through partition for a period of 6 months

In terms of the Cabinet decision, all state and state owned enterprise purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

1 PILLARS OF THE PROGRAMME

1.1 The NIP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$ 10 million or other currency equivalent to US\$ 10 million will have a NIP obligation. This threshold of US\$ 10 million can be reached as follows:

- b) Multiple contracts for the same goods, works or services each with imported content exceeding US\$3 million awarded to one seller over a 2 year period which in total exceeds US\$10 million.
or
- c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US\$10 million.
